



#### **ART. 1**

MOGAST *Mortirolo Gavia Stelvio – Three passes one day ride* is a non-competitive leisure cycling ride made from friends to friends based on quality time.

#### **ART. 2 – DATE and PLACE**

The ride will take place on SATURDAY 24 JUNE 2023 starting from Casanatura, SERNIO (SO), Italy

#### **ART. 3 – ROUTES and START**

MOGAST is based on a single route, starting from Sernio and arriving to Stelvio Pass passing through Mortirolo and Gavia for about 162 km (road version) and passing through Eita and Cancano for about 75km (gravel version).

Routes will not be signposted and each rider is expected to use the "Road Book". The maps and GPS routes may be consulted and downloaded from the Routes page on the [www.mogast.com](http://www.mogast.com) website.

Starting times will be at 8 o'clock of Saturday.

#### **ART. 4 – PARTICIPATION AND MEDICAL CERTIFICATE**

MOGAST is open to anybody of either sex who is over 15 years of age.

In 2023, according to Italian law, all cyclists must be members of a recognized club, following these procedures:

To participate MOGAST, ITALIAN cyclists who do not have a 2023 club membership issued by the Italian Cycling Federation (F.C.I.) or other Promotional Bodies (A.C.S.I., U.I.S.P., C.S.A.IN), must obtain "A.C.S.I. membership" (cost €10.00) which includes daily insurance cover for MOGAST;

FOREIGN cyclists who do not have a 2023 club membership issued by their national cycling federation and recognized by the International Cycling Union (U.C.I.), must obtain "A.C.S.I. membership" (cost €10.00) which includes daily insurance cover for MOGAST.

MOGAST staff will take care about activating the daily insurance. In order to let the staff activate the daily insurance cover and participate to MOGAST, it is OBLIGATORY to send a

**VALID MEDICAL CERTIFICATE for COMPETITIVE CYCLING**

The medical certificate must be valid on the date of the event (it must therefore be issued after 1 June 2022) and has to be sent by **31 may 2023**. If these conditions are not met, the cyclist will not be considered registered.

#### **ART. 5 - REGISTRATION METHODS AND FEE**

It is possible to register directly on the [www.mogast.com](http://www.mogast.com) website, with Paypal payment. Other forms of payment will not be accepted.

The registration fee of 60 € includes:

RIDE PACK with event gifts and souvenirs;  
ROAD BOOK which will be stamped at the checkpoints with details of the route and food stops.  
WELLCOME APERITIF on Friday night  
FOOD STOPS on Mortirolo, Gavia and Stelvio passes;  
PIZZOCCHERI PARTY at the end of the event;

#### **ART. 6 – CRITERIA REGARDNG BICYCLES**

At MOGAST, every kind of bikes are admitted which follow the rules of Italian law including functioning breaking system

We invite everybody to use a safety cycling helmet

#### **ART. 7 - RESPECT THE RULES OF THE ROAD**

MOGAST is a CYCLING EXCURSION mainly on asphalt roads; the whole route will be open to traffic for the entire duration of the event, and it is therefore obligatory that all participants respect the Rules of the Road. It is also mandatory to carry a repair kit for punctures and breakdowns.

#### **ART. 8 – MEDICAL CERTIFICATE**

Participation in the event is only permitted to those who have paid the registration fee and sent the Medical Certificate described in Art. 3 to the organization.

Cyclists who are not properly registered will not be permitted to participate and risk being removed. In case of accident, they will be held responsible for any damages caused.

The MOGAST organization may, incontestably, at any time, decide whether or not to accept a registration, without obligation to provide further explanation.

#### **ART. 9 – VALIDITY OF REGISTRATION**

Registration can be considered valid only when the electronic registration procedure has been completed, the corresponding amount has been credited to the organization, the medical certificate or documentation relating to membership of a recognized sport's club has been received and all of the above has been confirmed by the organization.

#### **ART. 10 - SUBSTITUTIONS OR CANCELLATIONS**

If a registered rider is unable to participate at MOGAST, It is possible to cancel the registration by contacting [mogast.info@gmail.com](mailto:mogast.info@gmail.com) by 15 may 2023.

After this date, the registration fee will not be reimbursed.

#### **ART. 11 – COLLECTION OF RIDE BRACELET.**

At Casanatura in Sernio, ride bracelets with an identification number for organization purposes will be distributed before the event, from Friday, 7 from 10:00 a.m. until 10 p.m. If someone would like to arrive at Saturday morning before the ride start, is kindly requested to contact the organization at

**ART. 12 – TIME LIMITS, ROUTE CLOSURE and ASSISTANCE**

The time limit within which the routes must be completed has been set at 18:00.

From that time, the check point at Stelvio Pass will close.

No type of medical assistance will be provided, apart from S.O.S. for medical emergencies, by calling the international emergency number 118. Mechanical assistance is not foreseen. By the way a car following the last rider will be provided. For serious breakdowns of your bike or if it's impossible for you to continue the ride, you can call the numbers provided on the roadbook and as soon as possible someone belonging to organization will pick you up along the ride.

**ART. 13 - FOOD STOPS, CHECKPOINTS AND FINISH OF ROUTES**

There are three OFFICIAL FOOD STOP (indicated on the MOGAST ROADBOOK), located on each pass (Mortirolo, Gavia and Stelvio) and in Cancano providing water, soft drinks, sweets, fruits, smiles, hugs and so on.

**ART. 15 – CANCELLATION OF THE EVENT**

If, for reasons of force majeure, the event does not take place, the registration fee will not be refunded or considered valid for the next year edition.

For reasons of force majeure the staff can decide, in any moment, to make changes to the route.

**ART. 16- APPROVAL, CONSENT, AUTHORISATION, ETC.**

When requesting to participate in MOGAST by any of the methods provided for by the current regulations, each participant, from the moment of registration:

declares that he/she has read and accepted the current Regulations in every part;

guarantees his/her own behavior during and after the event;

declares that he/she is physically fit and that he/she has delivered a valid medical certificate to the organization, having undergone a medical examination for the practice of competitive cycling, thus giving the organization the utmost leverage in the event of any damages resulting from his/her participation in the event;

gives the organizers the consent to use, according to the law, excluding for profit, any video or photographic images taken during the days of the ride only for MOGAST-related purposes.

The organization declines any responsibility, either direct or on the part of its collaborators, for any accident or damage to people or property, that may arise before, during and after the event or as a result of the same.
