



#### **ART. 1**

MOGAST *Mortirolo Gavia Stelvio – Three passes one day ride* is a non-competitive leisure cycling ride organized by friends for old and new friends and strictly based on quality time.

#### **ART. 2 – DATE and LOCATION**

The ride will take place on Saturday, June 28, 2025 starting from Casa Natura, SERNIO (SO), Italy

#### **ART. 3 – ROUTES and START**

MOGAST offers two possible different routes, road and gravel/MTB, both starting in Sernio and ending at Stelvio Pass.

Road route is approximately 115 km and includes the Mortirolo and Gavia Passes.

Gravel/MTB route is approximately 75 kilometers long and runs through Eita and Cancano.

Routes will not be signposted. Riders must navigate using the "Road Book" provided, as well as maps and GPS routes available for consultation and download on the "Routes" page at

[www.mogast.com](http://www.mogast.com) .

Ride start is set at 8 o'clock of Saturday 28 June 2025.

The GPX tracks are provided for guidance only: riders are expected to navigate the route independently from provided the GPX tracks.

#### **ART. 4 – PARTICIPATION AND MEDICAL CERTIFICATE**

MOGAST is open to all participants aged 18 and older, regardless of gender.

In accordance with Italian law, all participants must either:

1. Be members of a recognized cycling club (i.e. to own an UCI CARD), or
2. Follow the procedures outlined below:

Participants (Italian or foreign) who do not hold a UCI card for the current year as of the event date must provide a **VALID MEDICAL CERTIFICATE for COMPETITIVE CYCLING**.

The certificate must be valid on the event date (issued after June 28, 2024) and validated (see further) and submitted by May 31, 2025.

Failure to meet these requirements will result in disqualification.

The medical certificate must meet specific criteria and be validated through the specific **Data Health web platform**.

Please refer to the website ([www.mogast.com](http://www.mogast.com)) and download the corresponding medical form: either for foreign participants or Italian participants. It's strongly recommended to do so in order to understand the right typology needed and avoid any kind of issue during the validation process. The Data Health procedure is explained in every single step in the FAQ section of the website.

#### **ART. 5 - REGISTRATION METHODS AND FEE**

Registration can be completed on [www.mogast.com](http://www.mogast.com), with payment via PayPal. Alternatively, bank transfers are accepted (from EU countries only); details are provided on the website. No other payment methods are accepted.

**The registration fee is €80.**

**For participants reserving a camping spot (subject to availability), the fee is €90.**

The fee includes:

RIDE PACK with event gifts and souvenirs;  
ROAD BOOK which will be stamped at the checkpoints and detailing the route and food stops.  
WELCOME APERITIF on Friday night  
FOOD STOPS on Mortirolo, Gavia and Stelvio passes;  
PIZZOCCHERI PARTY at the ride's conclusion;  
Three days camping spot (if selected) with access to toilets and showers.

#### **ART. 6 – BICYCLE REQUIREMENTS**

All types of bicycles are allowed, provided they comply with Italian traffic regulations and are equipped with functional brakes.

Wearing an approved cycling helmet is mandatory throughout the event.

#### **ART. 7 - RESPECT THE RULES OF THE ROAD**

MOGAST is a CYCLING EXCURSION both on paved and unpaved roads; the route remains open to regular traffic for the event's duration. Participants must adhere to traffic laws and ride responsibly.

Carrying a repair kit for punctures and mechanical issues is mandatory.

#### **ART. 8 – VALIDITY OF REGISTRATION**

Registration can be considered valid only when the electronic registration procedure has been completed, payment has been received, the validation of the medical certificate or documentation relating to membership of a recognized sport's club has been received and all of the above has been confirmed by the organization.

Incomplete or late registrations, or those failing to meet requirements, will be rejected.

The MOGAST organization may, incontestably, at any time, decide whether or not to accept a registration, at its sole discretion, without obligation to provide further explanation.

#### **ART. 9 - SUBSTITUTIONS OR CANCELLATIONS**

If a registered rider cannot attend at MOGAST, they may cancel by contacting [info@mogast.com](mailto:info@mogast.com) before May, 1, 2025.

After this date, registration fees are non-refundable.

#### **ART. 10 –RIDE BRACELET COLLECTION.**

Each participant will receive a bracelet and identification number. Distribution will occur on Friday, June 21, 2025, from 10:00 AM to 10:00 PM.

Participants arriving on Saturday morning must inform the organizers at [info@mogast.com](mailto:info@mogast.com) in advance.

**ART. 11 – TIME LIMITS, ROUTE CLOSURE and ASSISTANCE**

The time limit within both routes must be completed has been set at 18:00.

After this time the check point at Stelvio Pass will close.

No type of medical assistance will be provided, apart from medical emergencies, by calling the international emergency number 118.

Mechanical assistance is not available.

**ART. 12 - FOOD STOPS, CHECKPOINTS AND ROUTES**

Four official food stops are detailed in the MOGAST Road Book, located at Mortirolo, Gavia, Stelvio and in Cancano providing water, soft drinks, salty and sweet snacks, fruits, smiles, hugs and so on. In Eita, participants will find a mountain hut where they can stamp their Road Book and purchase food or drinks.

By registering, participants:

Confirm they have read and accepted these regulations.

Acknowledge responsibility for their behavior during and after the event.

Confirm their physical fitness and provide a valid medical certificate.

Grant the organizers permission to use photos and videos taken during the event for non-commercial purposes.

The organization disclaims all liability for accidents or damages before, during, or after the event.

# Liability waiver for MOGAST Bike ride

In exchange for participating in the non-competitive bike ride MOGAST – Three Passes, One-Day Ride: Mortirolo, Gavia, Stelvio, scheduled for June 28, 2025, and being fully aware of the legal consequences of false declarations as well as the criminal penalties provided under Articles 46 and 76 of Presidential Decree 445/2000, I hereby, under my own responsibility:

## DECLARATION

- I am aware that this is a non-competitive event without rankings.
- I certify that I am physically fit to participate and have not been advised otherwise by a qualified medical professional. I confirm that no health-related issues or concerns prevent me from taking part in this bike ride.
- I acknowledge the route, its elevation profile, and the possibility of encountering challenging weather conditions (e.g., sun, wind, rain, hail, thunderstorms, cold, darkness, fog, snow, ice) or other hazards such as wild or unattended animals.
- I am fully aware of the traffic regulations and commit to adhering to them throughout the event.
- I fully accept the event rules without reservation.

## ACKNOWLEDGMENT AND ACCEPTANCE

- The route is identified through GPX tracks provided on [www.mogast.com](http://www.mogast.com). These tracks are solely for routing purposes, and participants are responsible for independently navigating the route.
- This is not a competitive ride but a free cycling tour without rankings or time limits.
- Each participant rides at their own risk and responsibility. Participants must consider themselves private individuals riding freely and hold no special rights over other road users.
- Each cyclist is solely responsible for their actions, particularly any violations of traffic regulations.
- The organizers do not provide medical, food, or mechanical assistance. There is no rescue service, and the organizers are under no obligation to search for participants along the route.
- The organizers are not required to supervise the route during the event.
- This is not an event organized by professional entities. It is conducted solely for recreational purposes and without profit, as defined under Article 1174 of the Italian Civil Code. Participation in MOGAST is entirely voluntary and recreational, and the organizers are exempt from any liability related to the event.
- No other entity bears responsibility for incidents that may occur during the event, including accidents, getting lost, health issues, injuries, theft, etc. MOGAST is to be regarded as a private and spontaneous gathering of amateur cyclists.
- By participating, I waive any right to pursue legal action against the organizers, acknowledging that they are non-professionals acting purely for recreational purposes.

## CONDITIONS OF PARTICIPATION

Registration and participation in MOGAST are strictly subject to full acceptance of the above terms and adherence to the following conditions:

- 1.Full compliance with traffic regulations.
- 2.Respect for the environment, including a commitment to keeping roads, forests, and lawns clean.
- 3.Strictly avoiding littering along the route and using designated garbage bins.
- 4.Wearing an approved cycling helmet at all times.
- 5.Avoiding large groups on the road that may obstruct normal traffic and, where possible, riding in a single file.
- 6.Using traffic-approved artificial lighting when natural light is insufficient.
- 7.Behaving respectfully towards other participants and individuals encountered along the route.
